## **Annual Report - 2016**

(And an Appeal for Support)

The overall goal of the Lili Kolisko Institute, a 501(c)3, not for profit organization, is to promote the spiritual and practical aspects of anthroposophy and anthroposophical medicine through research, education and social activities.

Briefly, in the last year we have:

- Written a book on the vaccination topic!
- Started research on the behavior of **potentized human blood**;
- Researched the difference between plants growing under the influence of "spraying" with potentized metal solutions, that are appropriate for that plant, vs. "non-sprayed" plants;
  - Researched the qualities of different **potencies of mistletoe**;
- Continued the "Kolisko Validation Process" for proving the quality and efficacy of growing list of commonly used anthroposophically potentized remedies.
  - Started research into the quality of Biodynamic Farming preps;
  - Created **new formulas** for remedies
- Conducted **study groups, given lectures and workshops** on anthroposophic medicine, eurythmy, etc.
  - Research on new treatments that take the stars into account.

Due to the many significant events of 2016 directly affecting the future of anthroposophic remedies it seems appropriate to start with the obvious question: Is the Kolisko Institute work relevant to these current needs of the time?

We think the answer is YES.

# A. The Research at our Institute counters the claim that potentized substances are only based on 18<sup>th</sup> century mystical, nebulous traditions

We have re-printed below an email announcement we have received from the AHPA organization (a national umbrella organization protecting herbal concerns.)


### FTC Issues Enforcement Policy Statement Regarding Marketing Claims for Over-the-Counter Homeopathic Drugs (sent 11.15.2016)

# Efficacy and Safety Claims Are Held to Same Standard as other OTC Drug Claims

The Federal Trade Commission today announced a new "Enforcement Policy Statement on Marketing Claims for Over-the-Counter (OTC) Homeopathic Drugs." The policy statement was informed by an FTC workshop held last year to examine how such drugs are marketed to consumers. The FTC also released its <u>staff report on the workshop</u>, which summarizes the panel presentations and related public comments in addition to describing consumer research commissioned by the FTC.

The policy statement explains that the FTC will hold efficacy and safety claims for OTC homeopathic drugs to the same standard as other products making similar claims. That is, companies must have competent and reliable scientific evidence for health-related claims, including claims that a product can treat specific conditions. The statement describes the type of scientific evidence that the Commission requires of companies making such claims for their products.

Homeopathy, which dates back to the 1700s, is based on the theory that disease symptoms can be treated by minute doses of substances that produce similar symptoms when provided in larger doses to healthy people. Many homeopathic products are diluted to such an extent that they no longer contain detectable levels of the initial substance. According to the



policy statement, homeopathic theories are not accepted by most modern medical experts.

For the vast majority of OTC homeopathic drugs, the policy statement notes, "the case for efficacy is based solely on traditional homeopathic theories and there are no valid studies using current scientific methods showing the product's efficacy." As such, the marketing claims for these products are likely misleading, in violation of the FTC Act.

However, the policy statement also notes that "the FTC has long recognized that marketing claims may include additional explanatory information to prevent the claims from being misleading. Accordingly, it recognizes that an OTC homeopathic drug claim that is not substantiated by competent and reliable scientific evidence might not be deceptive if the advertisement or label where it appears effectively communicates that:

1) there is no scientific evidence that the product works; and 2) the product's claims are based only on theories of homeopathy from the 1700s that are not accepted by most modern medical experts.

The policy statement notes that any such disclosures should stand out and be in close proximity to the product's efficacy message and might need to be incorporated into that message. It also warns marketers not to undercut a disclosure with additional positive statements or consumer endorsements reinforcing a product's efficacy. The statement warns that the FTC will carefully scrutinize the net impression of OTC homeopathic marketing claims and that if an ad conveys more substantiation than a marketer has, it will violate the FTC Act.

The Commission vote approving the enforcement policy statement and issuance of the staff report on the Homeopathic Medicine & Advertising Workshop was 3-0.

How do we counter these statements: with Our Kolisko Validation ™ Research

The results of our research clearly showed that potentized substances have a definitive effect on the biological life forces of plants in the laboratory, even when so highly potentized (so called ultra- high diluted and agitated) solutions of substances were used that no more physical substance would be demonstrated in the test solutions. This brings the influence of ultra-high dilutions (some of these potencies being part of what is called homeopathy some part of anthroposophically prescribed substances) **out of the realm of mysticism into the area of sold science. # B. The Research of the Kolisko Institute counters the increasing materialism appearing even in the homeopathic field

Rudolf Steiner valued Kolisko's work so highly (which we are continuing) since it allowed the proof that spiritual forces are directly and visibly working into the physical world.


This is especially important in our time when in spite of lip-service to the contrary materialism is actually quite widespread: the "mind" is only a reflection of neurotransmitters; acupuncture meridians are accepted only if physical structures can be demonstrated and electrical impulses shown to flow through them; and even homeopathy and potentized remedies are reduced to "nano- medicine", i.e. physical particles, not spiritual forces, are the active forces.

Astonishingly the American Institute of Homeopathy has released a short time ago a letter to conventional physicians trying to get them to give homeopathy a new consideration because:

"...Nanoscientists at 12 independent research labs have now consistently confirmed that all (potentized) medicines studied contain various nanostructures, including source and silica nanoparticles which are heterogeneously dispersed in colloidal solution – making homeopathic medicine the first known form of nanomedicine. What's more – we now know from recent discoveries in nanoscience that each remedy manufactured using traditional methods of trituration and vigorous agitation must in fact contain nanostructures."

This is where the research into the behavior of potentized substances, research done at the Kolisko Institute, can contribute to ensure that our voice for the recognition of the reality of spiritual impulses will be heard and respected. Rudolf Steiner was already pointing out in 1923

that Lili Kolisko's work demonstrated that the activity of substance potencies, potencies named by R. Steiner "the activity of the smallest entities" was due to spiritual material not forces.



### Is the Institute Research a "Social Impulse"?

Lili Kolisko knew that with her method she could help doctors find out which potencies of the remedies would be best suited to help in the clinical setting!

Unfortunately she could never realize her dream to cooperate with doctors in this direction.

Her work in the field of serial potencies was taken up in several variations over the decades but never in this cooperative direction of researchers working with doctors and patients to demonstrate that the resulting curves from the laboratory could be translated into practical applications like remedies which then would be used in clinical situations.

This is the direction we hope to go into and have already made some progress in.

As mentioned above, this work is especially important today in a time when the FDA is beginning to look quite closely at the reality of the "homeopathic" remedies.

This experimentation with its ensuing results could potentially be a significant factor in increasing the credibility, visibility and awareness of anthroposophical medicine for the future. Criteria for choosing potencies are a completely unsolved matter in spite of over 200 years of the existence of homeopathic practice.


#### This is an area where anthroposophists could have a leading role in the world.



In the last several years we have:

- Published articles, blog contributions, etc;

- Consulted in Waldorf Schools;
- Given radio interviews;

### **Current Status and Projected Needs**

Laboratory research and the educational work connected to it are very expensive.

- Materials need to be purchased;
- Co-workers' salaries covered;
- Facility has to be maintained;
- Outside help occasionally needed (statistical consultants, etc)

# We are facing this time a shortfall which if not resolved will lead to a long term interruption of our work!

The latest research (see our webinar) nearly exhausted our resources so that new donations are sorely needed.


To summarize, we believe that our research should be supported since:

- Very positive results are already obtained; not only can we show which potencies of the remedies are the most active but we are also beginning to conduct experiments showing the superiority of anthroposophical remedies vs. the other commercially available preparations;
- This work can help generate enthusiasm among present and especially among young upcoming physicians and lay people alike, showing that anthroposophy is creative and constantly renewing itself;
- These results can strengthen anthroposophical medicine, which then being more successful can in turn better support the Society as such.

We hope with your help to not have to interrupt our work.

This work directly helps all those who have in interest in or need of anthroposophical medicine!

A new phase is starting in the life of anthroposophical medical development. While it was enough up to now to become familiar with Rudolf Steiner's work, nearly 100 years after he laid the groundwork new demands are being made on us. Our desire to participate in discussions with our integrative and holistic colleagues must be accompanied by our ability to show that we "walk the talk".

Today one thinks that one has done enough with spiritual science when one has listened to her for a while, and when one believes that she may have had a beneficent, uplifting influence on our soul. **That is not enough!** Spiritual science must enter into all branches of life in practical actions. In all branches of life the fruits of spiritual science must show themselves." (2.18.1916)

This year we are working in memory of Lili Kolisko's 40<sup>th</sup> death day (November 20<sup>th</sup> 1976).
